HOW DOES HOMESURE COVER?



Houseowners

The policy covers the main buildings of the house, out-buildings within the yard e.g. garages, cottages, walls and fences demarcating the stand boundaries and all items fixed on the buildings e.g. electric gates, satellite dishes and alarms.

Covering Loss or damage to the houseowners caused by:

- ▶ Fire, lightning, explosion, earthquake & non-political riot.
- ▶ Storm, wind, hail or flood excluding loss or damage to property in the open.
- ▶ Bursting or overflowing of water tanks, apparatus or pipes excluding damage to the pipes themselves.
- ▶ Accidental breakage of windows, fixed glass in doors and sanitary fixtures except when the house is left unfurnished.
- ▶ Theft or attempted theft of landlord's fixtures and fittings.



Household contents

The policy covers the insured's property or for which he is responsible or for any member of his family, normally residing with him, and fixtures and fittings the insured owns, or for which he is responsible all in the buildings.

Covering Loss or damage to the houseowners caused by:

- ▶ Fire, lightning, explosion, earthquake & non-political riot.
- ▶ Storm, wind, hail or flood excluding loss or damage to property in the open.
- ▶ Theft or any attempted theft.
- ▶ Accidental breakage of mirrors, plate glass, and glass tops to furniture.
- ▶ Accidental damage to television sets and videos and aerials by external means.



The policy excludes property more specifically insure like Motor vehicles, Caravans, trailers, watercraft, livestock, Deeds, bonds, bills, documents and medals unless specified in the policy.
